coordination of the observational
evidence needed to understand
and manage the UK's changing
natural environment.

Launched in 2008 for the purposes of supporting better communication and sharing of information across the environmental observation community, UKEOF involves representatives from a range of organisations including government, research councils, devolved administrations and agencies. By informing the strategic direction of environmental observations and the efficient delivery of operational services, our collaborative approach supports policy, management, science and innovation for environmental and economic benefit.

Our Working Groups and workshops provide neutral spaces for organisations to share novel ideas, methodologies and solutions to problems, as well as to explore priority areas for environmental observations where a UK-wide perspective adds value. We also provide a range of resources to support transparent and evidence-based decision-making.

The UKEOF Secretariat is currently operated by the UK Centre for Ecology & Hydrology.

A Management Group oversees UKEOF's strategic direction, whilst the UKEOF Work Plan is delivered primarily through our Working Groups that meet regularly and are open to participants from outside the UKEOF consortium. The Working Groups are:

- Data Advisory Group (DAG) dedicated to fostering collaboration and innovation in environmental data sharing.
 The DAG facilitates knowledge exchange and the sharing of best practice, ensuring that the UK's environmental data and information resources are utilised to their fullest potential.
- Citizen Science Working Group (CSWG) a space for sharing good practice and discussing future needs and plans for working with volunteers to provide high quality, environmental observation data.
- Natural Capital Working Group (NCWG) bringing relevant organisations together to inform on national approaches and, where possible, align natural capital monitoring and reporting.
- UK DNA Working Group (UK DNA WG) facilitates
 dialogue and collaboration by providing a forum for the wide
 community of government agencies, academics and other
 stakeholders to discuss priorities and emerging developments
 in the use of DNA for environmental monitoring.
- Earth Observation Calibration and Validation Working Group (EOCV WG) - a forum focusing on linking observations across spatial scales, i.e. from ground observations to drones to satellites.
